The Black Friday In-store QR Code, Prize Card and Spin the Wheel Activation Competition

1. The Promoter

The promoter is River Island Clothing Co. Ltd, Chelsea House, Westgate, London, W5 1DR ("**River Island**"). River Island is a data controller under the General Data Protection Regulation and is registered with the Information Commissioner's Office. No provisions of these terms & conditions shall affect any statutory rights of entrants.

2. The competition

2.1 The title of the competition is **The Black Friday In-store QR Code, Prize Card and Spin the Wheel Activation Competitions** (the "**Competitions**").

3. How to enter

- 3.1 The Competitions will run from 09:00 on 28th November 2024 until 22:00 on 2nd December 2024.
- 3.2 All Competition entries must be submitted by 22:00 **no later than 2nd December 2024**. All Competition entries received after the Closing Date are automatically disqualified.
- 3.3 There are three (3) competitions in total (1) Scan QR Code; (2) Spin the Wheel; and (3) Prize Card. Entrants therefore have three (3) different mechanisms to enter each competition.

3.3.1 "Scan QR Code" ("Mechanism 1"):

- (a) Entrants must enter <u>any*</u> UK or Republic of Ireland River Island store;
- (b) Go into the changing room and scan the QR code on the fitting room mirror(s);
- (c) Once the Entrant has scanned the QR code, it will lead them to the River Island landing page which the entrant will reveal the 15% discount on a no minimum spend.

3.3.2 "Spin the Wheel" ("Mechanism 2") must:

- D) The arrow will land on a section of the wheel which will then determine the prize (15% off, 20% off, 25% off or a mystery prize).
- 3.3.3 "Prize Card" ("Mechanism 3") must:
 - (a) Entrants must enter <u>any*</u> UK or Republic or Ireland River Island stores;
 - (b) Pick up a prize card from one of the members of staff; and
 - (c) Once the Entrant has picked up the prize card, they can scratch the card to view which discount that they have won (15%, 20%, 25% off or a mystery gift card prize (one (1) £50/€50 River Island gift card per store per day).
 *any excludes Isle of Man and Jersey River Island stores.
- 3.4 River Island will not accept:

5.3 Mystery Prizes: The Mystery Prize will be in the form of gift card(s) from third party brands or River Island. The gift vouchers will state the period of validity.

5.5 The following Mystery Prizes (1) (£50/€50 RI gift card every day; and (2) £500/€500 Win your wardrobe), Mystery Gift Card Prize and any of the 25%, 20% and 15% Off Discount Card can be used together in one single transaction.

- 5.7 Prizes are subject to availability. There is no alternative for the Prizes.
- 5.8 The Prizes are supplied by River Island. River Island reserves the right to replace the Prizes with alternative prizes of equal or higher value if circumstances beyond River Island's control makes it necessary to do so.

6. Winners

- 6.1 The decision of River Island regarding the winners will be final.
