

River Island - Win –a £150 voucher + 2 Capital’s Summertime Ball with Barclaycard on Saturday 6 June 2026 Tickets - Terms and Conditions

1. The Promoter

1.1 The promoter is River Island Clothing Co. Ltd, Chelsea House, Westgate, London, W5 1DR (“**River Island**”). River Island is a data controller under the UK GDPR and the Data Protection Act 2018 and is registered with the Information Commissioner’s Office. No provisions of these terms & conditions shall affect any statutory rights of entrants. “**River Island**” is the registered trademark of River Island Clothing Co. Ltd.

2. The competition

2.1 The title of the competition is **River Island - Win A £150 voucher + 2 Capital Summertime Ball with Barclaycard 2026 Tickets** (the “**Competition**”).

3. How to enter

3.1 The Competition will run from 16:00 on 24th May 2026 (the “**Opening Date**”) to 09:00 on 29th May 2026 (the “**Closing Date**”) inclusive.

3.2 All Competition entries must be submitted by no later than 09:00 on the Closing Date. All Competition entries received after the Closing Date are automatically disqualified.

3.3 To enter the Competition, Entrants must:

3.4 Follow River Island;

3.5 Like the Competition post;

3.6 Tag the person they will bring to the Capital Summertime Ball with Barclaycard 2026 in the comments; and

3.7 Join the Instagram Broadcast Channel

3.8 River Island will **not** accept:

3.10 The Competition entries will be entered into a draw, and the winners will be selected by a computer process that produces verifiably random results. Winner will be announced on the Broadcast Channel.

4. Eligibility

- (b) Your tickets to Capital’s Summertime Ball with Barclaycard 2026 will be sent to you 24h before the concert via email through AXS ticket transfer. The tickets are subject to AXS’ Terms and Conditions. Concert takes place 6th June, tickets will be sent to you on 5th June.

(together the “Prizes”).

Prize at 5.1(a) – a £150 River Island Digital Gift Card + 2 Tickets to Capital’s Summertime Ball

- 5.2 The Prize at 5.1(a) is supplied by River Island. River Island reserves the right to replace the Prize with an alternative Prize of equal or higher value if circumstances beyond River Island’s control makes it necessary to do so.
- 5.3 The Prize is subject to availability. There is no alternative for the Prize. The Prize is not negotiable or transferable.
- 5.4 The prize and each element of the prize is non-transferable and may not be exchanged for cash. The prize may only be taken by the prize draw winner along with any accompanying person.
- 5.5 In order to claim the Prize, the winner must do so by responding to the message sent by River Island through direct messages on Instagram by no later than 9:00am on 1st June 2026

6. Winners

- 6.2 The decision of River Island is final, and no correspondence or discussion will be entered into.
- 6.3 River Island will contact the winner personally as soon as practicable via Direct Message, using the **Instagram** account used to enter the Competition. The winner will be announced on Instagram’s Broadcast Channel.
- 6.4 River Island must make available information that indicates that a valid award took place. To comply with this obligation River Island will send the surname and county of major prize winners and, if applicable copies of their winning entries, to anyone who emails customer.services@river-island.com within one month after the Closing Date of the Competition.
- 6.5 If you object to any or all of your surname, town or county and winning entry being published or made available, please contact River Island at customer.services@river-island.com. In such circumstances, River Island must still provide the information and winning entry to the Advertising Standards Authority on request.
