

## E- Receipt River Island Prize Draw

### 1. The Promoter

1. The promoter is River Island Clothing Co. Ltd, Chelsea House, Westgate, London, W5 1DR (“**River Island**”). River Island is a data controller under the General Data Protection Regulation and is registered with the Information Commissioner’s Office. No provisions of these terms & conditions shall affect any statutory rights of entrants. “**River Island**” is the registered trademark of River Island Clothing Co. Ltd.

### 2. The Prize Draw

1. The title of the Prize Draw is River Island Digital Receipt/”E-receipt” Prize Draw (the “**Prize Draw**”).

### 3. How to enter

1. The Prize Draw will run from 09:00 on 13th May 2026 (the "**Opening Date**") to 18:00 on 12<sup>th</sup> June 2026 (the "**Closing Date**") in (“**Selected Stores**”).
2. All prize draw entries must be submitted by no later than 18:00 on the Closing Date. All prize draw entries received after the Closing Date are automatically disqualified.
3. To enter the prize draw, Entrants must:
  - a. Head to the selected UK stores Dundee, Aberdeen Union Square, Inverness Shopping Park, Edinburgh Gyle, Livingston, Dunfermline, Edinburgh Fort Kinnaird, Glasgow Argyle Street, Glasgow Fort, Glasgow Parkhead, Stirling, Glasgow Braehead, Glasgow Silverburn, Glasgow Buchanan, Ayr Skye Square, Glasgow Braehead Kids, Carlisle and Workington.
  - b. Scan the QR code on the A4 Graphic at till points with your mobile device at the front of one of the Selected Stores; and
  - c. The QR code will take you to a landing page. Follow the steps on your mobile device to sign up to the River Island newsletter in which you will have the option to opt-in to marketing.
4. River Island will **not** accept:
  - a. responsibility for prize draw entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any

posting failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or

- b. proof of posting or transmission as proof of receipt of entry to the prize draw.
5. By submitting a Prize Draw entry, you are agreeing to be bound by these terms and conditions.
  6. The Prize Draw entries will be entered into a draw and the winner will be selected by a computer process that produces verifiably random results.

#### **4. Eligibility**

5. River Island reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the Prize Draw.

#### **5. The prize(s)**

1. There will be 1 winner in total. The winner will receive the Prize Draw Prize (“the **Prize**”) which is:
  - a. A £500 River Island gift card to spend either online or in-store across all ranges.
2. Prizes are subject to availability. There is no alternative for the Prize.

3. The Prize is supplied by River Island. River Island reserves the right to replace the Prize with an alternative prize of equal or higher value if circumstances beyond River Island's control makes it necessary to do so.
4. The Prize is not negotiable or transferable.
5. In order to claim the Prize, the winner must do so by responding to the message sent by River Island on 17<sup>th</sup> June 2026 via email by no later than 19<sup>th</sup> June 2026 by 23:59.

## **6. Winners**

1. The decision of River Island is final, and no correspondence or discussion will be entered into.
2. River Island must make available information that indicates that a valid award took place. To comply with this obligation River Island will send the surname and county of major prize winners and, if applicable copies of their winning entries, to anyone who emails [customer.services@river-island.com](mailto:customer.services@river-island.com) within one month after the Closing Date of the Prize Draw.
3. If you object to any or all of your surname, town or county and winning entry being published or made available, please contact River Island [customer.services@river-island.com](mailto:customer.services@river-island.com). In such circumstances, River Island must still provide the information and winning entry to the Advertising Standards Authority on request.

## **7. Claiming the Prize**

1. If you are the winner of the Prize Draw, you must claim the Prize by no later than 30<sup>th</sup> June 2026 by 23:59. If you do not claim the Prize by this date, your claim will become invalid.
2. The Prize may not be claimed by a third party on your behalf.
3. River Island will make all reasonable efforts to contact the winner. If the winner cannot be contacted or is not available or has not claimed their Prize by no later no later than 23:59 on 30<sup>th</sup> June 2026.
4. River Island reserves the right to offer the Prize to the next eligible Entrant selected from the correct entries that were received before the Closing Date.
5. River Island does not accept any responsibility if you are not able to take up the Prize.

## **8. Limitation of liability**

1. Insofar as is permitted by law, River Island, its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the Prize except where it is caused by the negligence of River Island, its agents or distributors or that of their employees. Your statutory rights are not affected.

## **9. Ownership of Prize Draw entries and intellectual property rights**

1. All Prize Draw entries and any accompanying material submitted to River Island will become the property of River Island on receipt and will not be returned.

3. These terms and conditions shall be governed by English law, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales.
